



# South African Firearm License



## What do we do?

- We compile your entire license application – this includes a comprehensive motivational letter, completion of all your SAPS forms and all other relevant documentation.

## What should you do?

- Supply us with the necessary information and documentation for the application – for your convenience as well as a faster service, we will keep it on file for future applications.
- According to the Firearms Control Act, an applicant must hand in their application for competency/license in person at the DFO at the police station closest to their home address.
- You therefore simply sign the application and documents accompanying it, and hand it in at SAPS.

## What we will need from you:

### FIREARM DEALER/ AMNESTY APPLICATION/ RENEWAL OF LICENSE.

- SAP 271 form from firearms dealer – **New license.**
- SAPS 271 we will supply for **Renewal** and **Amnesty**
- For renewal or amnesty you should supply us with the license that needs attention (front and back copy)
- For renewal or amnesty you should supply us with the license that needs attention (front and back copy)

### IMPORTANT TO REMEMBER

- You are only allowed to own 1 x self-defence and 3 x occasional
- After this you need to do dedicated status
- You need to certify you ID, proof of residence and competency after you picked up your application – unfortunately we can't do it for you
